Style Guide

The initial submission does *not* have to be specially formatted. It should be in English and should NOT contain the following as these will be added automatically by Digital Commons:

- any identifying information or metadata
- a title page or abstract
- footnotes in the body of the paper
- page numbers, headers, or footers

Accepted Manuscripts

Once a manuscript has been accepted, it must be formatted using the IEEE conference template, available from the link on the CCERP Digital Commons home page. In addition to the requirements of the template, all accepted manuscripts **must**:

- include all authors information,
- include an ORCID (www.orcid.org) number for each author, after the email address at the top of the manuscript, if you do not have an ORCID number, you may obtain one for free from the above web site,
- include DOIs where available for all references,
- remove the IEEE copyright notice in the bottom margin,
- check for fit after uploading. In checking fit, ensure the title does not overlap with the header information added by Digital Commons.

For the CCERP conference, if it is co-hosted with the Colloquium for Information Systems Security Education (cisse.info), the proceedings may be published WITH the Journal of CISSE, but not IN the journal. The electronic copy of the proceedings will be published on the CCERP Digital Commons site.
