- Wasim Alhamdani's article "Adopting the Cybersecurity Curriculum Guidelines to Develop a Secondary and Primary Academic Discipline in Cybersecurity Postsecondary Education" examines the role of ACM guidelines and the NSA/DHS CAE in Cyber Ops program on secondary Cybersecurity education.
