He was a visiting scholar at Dankook University in South Korea and a visiting Fulbright Scholar at Kennesaw State University during the Year of Peru (2011-12).

Julio Ortega is Professor of Hispanic Studies at Brown University. He is an accomplished scholar and writer, with 15 books as well as several critical editions to his credit. He has also been a visiting professor at numerous universities both in the United States and abroad, including terms as Simon Bolivar Professor of Latin American Studies at the University of Cambridge (1995-96) and Cátedra de Estudios Avanzados at the Universidad Central de Venezuela (Summer 1995). Professor Ortega's commitment to literature goes beyond his own writing and teaching to include his contribution as editor of series of scholarly works and new writing in Mexico and Madrid. He has been the editor of critical editions of works by Rubén Darío, César Vallejo, Jorge Luis Borges, and Julio Cortázar.

Dan Paracka is Director of Education Abroad and Associate Professor at Kennesaw State University, where he also coordinates the signature Annual Country Study Program. His areas of scholarship center on processes of international education and intercultural learning. He is the author of *The Athens of West Africa: A History of International Education at Fourah Bay College*. He was the co-organizer of the Year of Peru (2011-12).

Luis Ramos-García is Associate Professor in the Department of Spanish and Portuguese at the University of Minnesota. A native Californian with long-term ties to the Silicon Valley, he has worked out of Lima, Peru, on and off for over two decades while carrying out research in Asia, Africa, and Latin America. Victor Vich is the Coordinator of the Master in Cultural Studies Program at the Pontificia Universidad Católica del Perú and the Principal Researcher at the Institute of Peruvian Studies. He is the author of four books: *Street Performers and the Tension of Modernity in Peru*, *The Other Guy is the Cannibal: Violence and Culture in Contemporary Peru*, *Orality and Power* (with Virginia Zavala), and *Against the Dream of the Righteous: Peruvian literature in Times of Political Violence* (with Juan Carlos Ubilluz and Alexandra Hibbett). He was a visiting professor at Harvard University in 2007, and in 2010 he won the Guggenheim Fellowship. He also served as a member of the Steering Committee of the Latin American Council of Social Sciences (CLACSO 2007-09).
