Manuscripts and related correspondence should be addressed to Editor Heather Oswald (provenance@soga.org). Review materials and related correspondence should be sent to Reviews Editor Jennifer M. Welch (welchje@musc.edu). The Editorial Board evaluates submitted manuscripts in terms of appropriateness, scholarly worth, and clarity of writing. Contributors should not submit manuscripts simultaneously for publication in any other journal. Only manuscripts that have not been previously published will be accepted, and authors must agree not to publish elsewhere, without explicit written permission, a paper submitted to and accepted by Provenance.
